#### **EXAMINATION ADMINISTRATION**

The Property Maintenance Examination is given at Florida Community College Jacksonville (FCCJ) Downtown Campus. After your application has been processed you will receive an admission slip, instructions for scheduling and taking the examination, and directions to the site.

You should report to the examination site no later than the time reserved. It is recommended that your arrive at the site fifteen (15) minutes prior to the examination reporting time.

Bring your admission slip to the test site. You will be required to show it and turn in your voucher to gain entry into the examination room. Your admission slip will have an expiration date of 90 days.
